# STYRELSENS FÖR TRIBORON INTERNATIONAL AB REDOGÖRELSE ENLIGT 13 KAP. 6 OCH 14 KAP. 8 §§ AKTIEBOLAGSLAGEN

Teckningskursen uppgick till 0,231361 kronor som motsvarar åttio (80) procent av den volymsviktade genomsnittskursen för aktier av serie B baserat på de tio föregående handelsdagarna före dagen för stämman. Teckning av aktier ska ske på teckningslista senast två (2) veckor efter dagen för bolagsstämman. Emissionslikviden ska erläggas genom kvittning av respektive fordran. Kvittning ska ske vid teckningstidpunkten. Aktiekapitalet kan genom emission öka med högst 262 500 kronor.
